Pursuant to revisions in the HLC Guidelines *Determining Qualified Faculty through HLC's Criteria for Accreditation and Assumed Practices* B.2. pertaining to the qualifications of faculty and the importance of faculty members having appropriate expertise in the subjects they teach, and university policy <u>http://www.utoledo.edu/policies/academic/faculty_staff/pdfs/3364-72-11.pdf</u>, Dr. Hans Gottgens presented revisions to UT's Graduate Faculty Membership Application and membership category definitions. The following has been added to the application for clarification of credentials/expertise.

Is this the Terminal Degree in your Discipline? Yes or No

For those graduate faculty applicants holding less than a terminal degree outline how the applicant meets the university's minimum threshold of five years of experience or demonstrated skills in the same area in which the potential instructor will be teaching. This may include breadth and depth of experience in real-world relevant situations to what the faculty is teaching and/or industry credentials.

Membership category definitions: Associate, Professional and Adjunct had the following italicized language added:

Hold an earned terminal degree: Alternatively hold an earned Master's degree and possess equivalent experience to a terminal degree as documented through an evaluative review process.

Ms. Terri Hayes in COGS has also reformatted the application information section for clarity of information to in distinguishing internal and external applicants.
