Report of the Executive Committee of the Graduate Council and the Dean of the College of Graduate Studies

Dr. Dowd stated the work on the Bylaws and Constitution needs to continue during the summer. A draft version would be distributed to Graduate Council members when it is available. Feedback will be useful for a final version which should be completed in early fall semester and submitted to the graduate faculty for consideration.

Be it resolved that the Graduate Council expresses its deep gratitude to Dr. Constantine Theodosiou for his service as Interim Dean of the College of Graduate Studies during the 2007-2008 academic year, and especially for his significant efforts on behalf of graduate studies within a changing environment at our University.

Be it resolved that the Graduate Council expresses its sincere appreciation to Ms. Terri Hayes for her outstanding efforts in support of the work of the Graduate Council and its committees throughout the 2007-2008 academic year.

Dr. Theodosiou suggested the present Graduate Council Executive Committee (GCEC) continue until the beginning of fall semester and the new GCEC can work with the previous GCEC and elected committee members should be committed to be available this summer. Dr. Dowd questioned the validity and value in suspending the rules for delaying the election of officers until the fall semester. This was followed by a spirited discussion.

Information and Discussion Items

Motion to Extend Early Admission into MPA in Political Science and Economics (following same policies and procedures as Engineering)

The GCEC did not forward a motion at this time because this request has not yet been reviewed by the Arts and Sciences Council, and hence, it would be premature for Graduate Council to fully consider this proposal at this time.

Status Update on College of Graduate Studies Dean Search

Dr. Bjorkman gave an update on the status of the dean candidates' visits to campus. Two candidates have already made a campus visit and the third is scheduled for this week, followed by the fourth candidate, Dr. Constantine Theodosiou, on Friday, May 2nd Monday, May 5th. The Council is encouraged to attend the receptions and open sessions. The Graduate Council expressed appreciation to Ms. Terri Hayes for her assistance in notifying graduate faculty of these events.

Election of Officers for 2008-2009

[Motion – approved]

Propose holding elections to vote for new officers and also to extend the current GCEC until the end of summer.

Dr. Bjorkman noted that according to the Bylaws, elections must be held by the new Graduate Council members for next fall and there is no provision to extend the rules. Dr. Bjorkman stressed the importance of a new executive committee being in place during the summer months. However, new elections may be necessary in the fall if the Bylaws are revised and are not in agreement with our current Constitution and Bylaws. The officers need to be a part of the process in the summer for reconciling both documents and will send for a vote in the fall. It was noted that the graduate faculty on both campuses would need to review and approve such documents. The new GCEC should be involved in such summer discussions and keep up to date on the evolving issues.

Dr. Theodosiou stated that as of July 1st, there will be one Graduate College operation.
