Intellectual Property...Ownership of intellectual property rights in discoveries, inventions and patents is determined in accordance with Ohio Revised Code, Section 3345.14. I hereby agree to report any patentable inventions and discoveries arising from any of research, investigation, study, or other scholarly activity performed during my visit to personnel identified as being responsible for the administration of patent matters at UToledo in accordance with the procedures established by UToledo. I hereby assign and transfer to UToledo the entire right, title, and interest, in and to each invention and/or discovery in accordance with the UT patent policy and Section 3345.14 of the Ohio Revised Code.

Publications.... Publication of the results of research performed at UToledo is permitted after review by the UToledo Individual Host and by Sponsor, when required by a sponsored agreement funding the research. I understand that publication may be delayed permitting the Sponsor or UToledo to protect intellectual property resulting from the research.

Compliance & Other Requirements

I certify that I am qualified to perform the tasks that I will undertake at UToledo.

I agree to maintain accurate and complete laboratory notebooks and/or other written documentation that is appropriate for the purpose of this visit, as determined by UToledo and in compliance with all UToledo policies.

I understand that the research may involve risks such as exposure to potentially hazardous equipment, chemicals, microbes, infectious organisms, medical waste, pathogens, laboratory animals, radioactive material, and the risk of accidents and injuries.

I agree to cooperate fully with the UToledo Individual Host or designee to obtain any required training, approvals, or authorizations for performance of the tasks at UToledo, in accordance with UToledo policies and procedures and applicable laws, regulations and standards.

I agree to comply with export and sanctions regulations of the United States of America. I understand that UToledo may review all UToledo activities that may result in an export or sanctioned transaction with a foreign national, entity or country requiring an export license or other governmental approval. I agree to cooperate with any such review and to comply with any recordkeeping, certification, license, security measure or other action that may result from the review.

My participation as a Visiting Scholar at UToledo shall not create an employment relationship between UToledo and me. I understand that if not employed by UToledo I am not covered by general or professional liability insurance for claims and judgments arising out of my activities. I shall receive no financial support from UToledo for their effort beyond travel and/or expense reimbursements and/or an honorarium, where appropriate and applicable, and at the discretion of the host college or department. In addition to all foregoing obligations, Visiting Scholars will comply with all UToledo rules and regulations applicable to the Visiting Scholars during their presence at UToledo and will follow the directions and guidance of the Individual Host.

The Visiting Scholar and Sponsor agree to indemnify and hold harmless UToledo, its Board of Trustees, officers, and employees from and against all claims (including claims of negligence), damages, cost, and expense (including attorneys' fees) that arise from the acts or omissions of Visiting Scholar during the term of this Agreement. Such indemnity obligation shall not apply to claims that arise solely from the sole negligence of UToledo.
